



Dubai trip Terms and Conditions

I. Interpretation / Abbreviations

“Company” shall mean Fintokey a.s., a company incorporated according to the laws of the Czech Republic, Registration number 09110127, having its registered office at Masarykova 409/26, 602 00 Brno, Czech Republic.

“Fintokey” shall mean Company.

“Draw” shall mean a draw organized by the Company designed to provide the Participants with the opportunity to win a Prize in accordance with the Terms.

“Draw period” shall mean a period during which Participants eligibility is evaluated and gained. After every Draw period is finished, Winner is picked.

“Offer” means SUMMERBOOST - Summer 2025 Limited offer and/or related landing page.

“Participant” shall mean any natural or legal person registered as Client with the Company.

“Terms” shall mean these terms and conditions.

“General Terms” shall mean Fintokey general terms and conditions applicable for any Client.

“Disqualification” shall mean termination of participation in the Draw without the right to win the Prizes.

“Client” definition is specified in art. V.2. below.

“Prize” shall mean the prize awarded to the Winner.

“Winner” the Participants picked during the draw as per the art. V.

II. Eligibility

- 1) The status of participant requires to be over 18 years of age, of full legal capacity and fully entitled to engage in the Terms.
- 2) By participating in the Draw to actually compete and eventually win, you acknowledge that you have read and agreed to be bound by these Terms as well as to the General Terms specified therein.
- 3) The Company employees, contractors and/or similar are not eligible to participate in the Draw.
- 4) Eligibility status remains at sole discretion of the Company.

III. Registration

- 1) There is no further requirement for registration for the Draw. Participation in the Draw is automatic for all Clients irrespective of whether they have acquainted themselves with the Terms.
- 2) No extra registration fee required.

IV. Draw period

- 1) The Draw period and its timeline is defined in the Offer.
- 2) The company reserves the right, at its discretion, to either shorten or extend the duration of the Draw period at any time.

V. Rules of the Draw

1. Participants are required to attract as many individuals / legal persons as possible to become Clients.
Every purchase of the Client counts as 1 ticket to be included to a lottery machine.
2. Definition of Client and their purchase is as follows:
 - a) the user purchased Company services defined in the Offer.

- b) The Client purchase is not terminated by Client within 14 days of its conclusion or within statutory period that allows Client as consumer to rescind/terminate such purchase therefore the purchase might be recognised as legit for Draw period after 14 days from purchase was made provided the purchase cannot be rescinded / terminated due to other reasons specified in General Terms.
- c) Purchases which utilized Prohibited Trading as per General Terms shall not be counted.
- 3. Subsequently the Company shall draw a Winner, who will be selected randomly using an online random generator after verification of all entry requirements.
- 4. Winners will be announced on the website and respective social media platforms including contacted via direct message / email. Winners must respond and confirm their acceptance within 5 business days of notification. If a winner fails to respond within this period, their prize will be forfeited and an alternate winner will be selected.
- 5. The company reserves the right, at its discretion, to modify the parameters of the Rules specified herein and to change a character of the Draw entirely at any moment during the Draw period.

VI. Prohibited activities

- 1. Prohibited activities are defined in General terms.
- 2. Should a Client commit any misconduct against the rules defined in the General terms during a Draw period, such client does not count as a Client as per the Terms.
- 3. Disqualification:
 - a) Any conduct of Prohibited activities defined herein or in the Terms at any time during Draw period,
 - b) Fintokei reserves the right to disqualify Participants that do not adhere to the rules set forth in these Terms without prior notice.
 - c) Should Fintokei suspect that a Participant engaged in dishonest and unfair conduct, then Fintokei reserves the right to immediately disqualify the participants from the Draw without the consent and/or prior notice of the Participants.

VII. Liability

- 1. To the fullest extent permissible by law, you expressly waive any rights to litigate, seek injunctive relief, or engage in any form of judicial or alternative dispute resolution process arising from or related to this Draw. This waiver includes, but is not limited to, any claims or disputes regarding eligibility, participation, prizes, or any other aspect of the Draw.
- 2. The Company makes no guarantee, representation, or warranty, express or implied, regarding the probability of winning any prize. Participation in the Draw is at the sole risk of the Participants.
- 3. The Company shall not be held liable for any losses, damages, injuries, or inconveniences incurred by the Winner in connection with the Prize (especially if the Prize includes travelling, hotel accommodation and/or other services). This includes, but is not limited to, the following circumstances:
 - a) Third-party providers: The Company is not responsible for the actions, omissions, or negligence of third-party service providers, including but not limited to airlines, hotels, transportation companies, tour operators, or other entities that provide services related to the tour,
 - b) Force majeure: The Company shall not be liable for any failure or delay in the performance of its obligations due to circumstances beyond its reasonable control, including but not limited to natural disasters, war, civil unrest, strikes, pandemics, or governmental actions,

- c) Changes and cancellations: The Company reserves the right to modify, reschedule, or cancel the tour for reasons including but not limited to insufficient participation, safety concerns, or unforeseen events. The Company shall not be liable for any losses or additional costs incurred by the Participants as a result of such changes or cancellations.
 - d) Personal conduct and Safety: The Participants are responsible for their own actions, personal conduct, and safety during the tour. The Company shall not be liable for any injuries, losses, or damages resulting from the Participants' actions or failure to adhere to safety guidelines and instructions provided by the tour guides or local authorities.
 - e) Travel documents and insurance: The Participants are responsible for ensuring that they have the necessary travel documents (e.g., passports, visas) and travel insurance coverage. The Company shall not be liable for any issues arising from insufficient or improper documentation or lack of insurance coverage.
 - f) Personal belongings: The Company shall not be responsible for the loss, theft, or damage of personal belongings during the tour.
- 4. If the Prize includes travelling, accommodation and other related services, the Company under no circumstances operates as a travel agency.
 - 5. By participating in the tour, the Participants acknowledge and agree to the Terms of this Non-Liability Clause and release the Company from any claims or liabilities arising from their participation in the tour.

VIII. Prizes

- 1) The Specification of the Prize shall be published by the company at the beginning of every Draw period at the latest, though Fintokei reserves the right to modify it anytime.
- 2) During the Prize revelation the Company shall publish also conditions of the Prize depending on the Winner's performance after related Draw period is finished.
- 3) The Company reserves the right to fully revoke the Winner's prize if the Winner fails to provide the necessary participation and information required for the reception of the Prize. This includes, but is not limited to, details necessary for the booking of flight tickets, hotel accommodations, and other related arrangements. If a winner fails to respond within reasonable period, the Prize will be forfeited and an alternate winner will be selected.
- 4) For the avoidance of any doubt, the Company does not bear under any circumstances a liability as per the art. VII.

IX. Marketing cooperation and privacy policy

- 1) Participants acknowledge and accept that:
 - a) in case they are awarded with a prize by Fintokei, they may be asked to participate in promotional events, interviews, public announcements in connection with the Draw and that Fintokei might make use of their names or Nicknames, Client history and references for at least 1 year after the announcement of the Winners on Company's Website,
- 2) Each Winner also agrees:
 - a) to eventually share his/her photo and allows Fintokei to use that photo in promotional materials created by the Company.
 - b) that the Company will make audiovisual materials during the winning ceremony.
 - c) that his profile, history, marketing and visual materials may be used in the promotion for the next rounds of the Draw.

X. Other Terms



1. Fintokey retains the discretion to cancel or revoke the awarding of Prizes if they are mistakenly granted.
2. Fintokey reserves the sole discretion to modify, amend, suspend, or terminate this Contest, or any part thereof, including extending the contest period, at any time and without prior notice. In such circumstances, Fintokey will endeavor to notify you via email.
3. If the Competition cannot proceed as intended due to factors beyond Fintokey's control, including but not limited to technical malfunctions, Fintokey shall bear no responsibility or liability to anyone regarding the Draw.
4. Should any provision of these Terms be deemed invalid or unenforceable, the remaining provisions shall remain in full force and effect.
5. All winners are solely responsible for the payment of any applicable taxes, including federal, state, and local taxes, arising eventually from the winning of the Prize.
6. In the event of any dispute or misinterpretation of these Terms or the Draw, Fintokey shall resolve such disputes or misinterpretations and shall act in good faith and deem fit and proper. If the dispute is not resolved in an amicable way, then the dispute shall be resolved by the courts of Czech Republic.
7. Fintokey reserves the right to change any specification of the Draw and suspend, postpone or cease the Draw at any time entirely and at its sole discretion without prior notice. Any changes shall be posted on the Fintokey's website and from the moment of such change notification posted it is considered that the Participant accepted such changes.
8. In the event of translation of these Terms, the English version shall prevail. Terms and the disputes arising from the Draw shall be governed by and enforced in all respects by the laws of Czech Republic.
