

## Fintokei Contest Rules

### Interpretation / Abbreviations:

“**Company**” or “**Organizer**” shall mean Fintokei a.s., a company incorporated according to the laws of the Czech Republic, Registration number 09110127, having its registered office at Masarykova 409/26, 602 00 Brno, Czech Republic.

“**Fintokei**” shall mean Company.

“**Contest**” definition is specified in art. 1 below

“**Participant**” shall mean any natural or legal person which is eligible to participate,

“**Terms & Conditions**” or “**Terms**” shall mean this terms and conditions

“**Disqualification**” shall mean termination of Participant’s participation in the Competition without the right to win the Prizes – specification below.

“**Prizes**” shall mean the awards awarded to the Participants.

“**Winner**” the Participant(s) which wins the Contest.

### 1. GENERAL

This Contest ("Contest") is organized by Fintokei. The Contest gives participants the opportunity to win Prizes. The Contest is subject to these Contest Rules, and by participating, each entrant agrees to be bound by them.

### 2. ORGANIZER AND OPERATOR

These Contest Rules (hereinafter "Rules") are issued by **Fintokei a.s.**, with registered office at Masarykova 409/26, 602 00 Brno, Czech Republic, Registration No. 09110127, registered in the Commercial Register maintained by Regional Court in Brno (hereinafter "Organizer").

### 3. CONTEST DURATION

The event includes following contest (individually as "Contest Periods"):

- The contest begins on 25<sup>th</sup> May 2026 and ends on 31<sup>st</sup> May 2026 at 23:59 (Central European Time).

The Contest period might be prolonged by Fintokei at its sole discretion any time during the Contest period.

### 4. ELIGIBILITY AND DISQUALIFICATION

#### 4.1 Eligibility Requirements

The Contest is open to all individuals aged 18 years or older, who are adult and fully entitled to engage in the Contest. Employees of the Organizer, their immediate family members, and persons involved in the Contest organization are not eligible to participate. It is also not permissible to participate for citizens from banned countries – specified [here](#).

#### 4.2 Disqualification

The Organizer reserves the right to disqualify participants from the Contest without prior notice in the following cases:

- a) Use of automated systems, bots, or other artificial methods of participation
- b) Creating multiple accounts or using fake profiles
- c) Engaging in dishonest, fraudulent, or unfair conduct
- d) Harassment of other participants or posting offensive content
- e) Providing false or misleading information
- f) Withdrawal of consent for personal data processing before Contest completion

#### **4.3. Verification Rights**

The Organizer reserves the right to verify compliance with all Contest conditions at any time, including after the Contest has ended. If a winner is found to have violated any rules, the Organizer may revoke their prize and select an alternative winner.

### **5. HOW TO ENTER**

To participate in the Contest, entrants must complete all of the following requirements:

Participants make purchases using the code FIN10MEGA, which has no limit on the number of uses and does not include any discount.

### **6. PRIZES AND WINNER SELECTION**

#### **6.1. Prizes**

The Contest will have five winners from those who purchased with the code FIN10MEGA. Each winner will receive one **Challenge ProTrader account**, valued at €100,000 / \$100,000 / 2,000,000 CZK.

Should the prize include a free Fintokei product and the winner is not eligible to purchase new Fintokei products due to a prior decision / restriction imposed by Fintokei, such winner shall be disqualified, and all rights might be transferred to the next eligible participant.

The prize cannot be transferred, exchanged for cash, or sold to third parties. The Organizer reserves the right to substitute the prize with another of equivalent value if circumstances require.

#### **6.2. Winner Selection and Prize Delivery**

After the Contest ends, winners will be selected randomly using an online random generator. Winners will be contacted via email on 15<sup>th</sup> June 2026. Winners must respond and confirm their acceptance within 3 business days of notification. If a winner fails to respond within this period, their prize will be forfeited and an alternate winner will be selected. The prize details will be sent to the winner via direct message.

### **7. GENERAL CONDITIONS**

#### **7.1 Entry Conditions**

The Organizer reserves the right to disqualify any entries containing inappropriate or offensive content. The winner has to have an account on <https://my.fintokei.com/login>.

#### **7.2. Prize Conditions**

Prizes are awarded as described and no cash alternatives or substitutions will be offered. Prizes are non-transferable and cannot be exchanged for other items or monetary value. The Organizer reserves the right to substitute a prize of equal or greater value if the original prize becomes unavailable.

### **7.3. Organizer Rights**

The Organizer shall not be held responsible for any technical issues that may affect participation in the Contest. The Organizer maintains the right to disqualify any participants who violate these Rules or engage in fraudulent behavior. In case of disputes, the Organizer's decision shall be final and binding. The Organizer may modify these Rules with appropriate notice to participants.

## **9. CONSENT AND PERSONAL DATA PROCESSING**

### **9.1. Voluntary Participation and Consent**

The Organizer processes only the personal data provided by participants necessary for contest administration and prize delivery. The Organizer will retain personal data in accordance with the [consent](#).

### **9.2. Data Access and Processing**

Personal data will be accessible only to authorized personnel of the Organizer and will be protected against unauthorized access. The Organizer ensures that no unauthorized third parties will have access to participants' personal data. Participants may withdraw their consent at any time by sending an email to the Organizer. However, withdrawal of consent before the Contest completion will result in disqualification from the Contest.

### **9.3. Data Protection Rights**

Participant's personal data are furthermore governed by Fintokei [privacy policy](#).

## **10. LEGAL BASIS AND CONSUMER PROTECTION**

This Consumer Contest is governed by the **Consumer Protection Act** (Act No. 634/1992 Coll., as amended) of the Czech Republic, under which marketing contests are considered a commercial practice. According to the Consumer Protection Act, a consumer contest is defined as a competition, survey, or other prize-based activity organized for consumers in direct connection with the promotion, offering, or sale of products or services by the seller.

The Organizer ensures full compliance with all provisions of the Consumer Protection Act and related regulations governing consumer contests in the Czech Republic. All participant rights and protections stipulated by this legislation are fully honored within these Contest Rules.

## **11. FINAL PROVISIONS**

### **11.1. Modifications**

The Organizer maintains the right to modify these Rules or contest conditions, including its duration, or terminate the contest entirely without compensation.

### **11.2. Technical Issues**

The Organizer cannot be held responsible for any technical problems or malfunctions that may affect participation in the Contest.

### **11.3. Liability**

The Organizer assumes no responsibility for any damages or losses related to participation in the Contest, including those connected to contest preparation, execution, or prizes. To the extent permitted by law, your rights to litigate, to seek injunctive relief, or to any other recourse to judicial or any other procedure in case of disputes or claims resulting from or in connection with this Contest are hereby excluded, and you expressly waive any and all such rights.

### **11.4. Agreement to Rules**

By participating in the Contest, individuals acknowledge that they have read, understood, and agree to be bound by these Rules and commit to comply with them fully.

Fintokei [General terms](#) are applicable accordingly.

### **11.5. Legal Enforcement**

Participation in the Contest cannot be legally enforced, and no legal claims can be made regarding the Contest outcome.

### **11.6. Governing Law**

The Contest and all relationships between participants and the Organizer are governed by the laws of the Czech Republic. Any disputes will be resolved according to this jurisdiction.
